3. Presentation

3.1 Thrive Nation

Dr. Dale Marsden introduced Thrive Nation Foundation's mission and Co-Founder and Board President, Rick Schreiber: Thrive Nation is a national non-profit that offers personalized, one-on-one coaching to young adults ages 18-25. The mission is to help them thrive by 1) aligning their passion and strengths with their career and life, 2) accelerating and enhancing life and work related skills and 3) helping to facilitate higher completion and placement rates.

Rick Schreiber and Wendy Battino shared that as a result of significant technological and societal trends, millennials and iGens (the post-millennial generation), need help more than ever. Through Thrive Nation's coaching and strategic connections, Thrivers realize their goals, develop skills, self-belief, compassion and resilience. They are seeking to extend the reach to young adults in high-need areas and welcome the opportunity to collaborate with new partners.

Thrivers, Benjamin Montelongo, Tania Lima, and Edgar Diaz, summarized how Thrive Nation helped them reach their goals in both, the classroom and personal setting.

Ms. Diaz asked how the connection was made with the coach in London and how were they able to connect with them due to the time difference.

Mr. Diaz replied that there was no conflict of time.

Ms. Alvarez asked how the connection was made with Thrive Nation.

Ms. Lima replied that the connection was made through the, "Making Hope Happen Scholarship."

Ms. Rodriguez asked if there was a cap as to the number of students that could participate in Thrive.

Dr. Marsden replied that the goal is to take it nationwide and Mr. Schreiber mentioned that they are prepared to scale it up.

Dr. Houston shared that there was a Workforce Project from 2012-2016 in San Bernardino and Imperial County called, "At Life," and there were 664, ages 18-24, disconnected youth served. All the current WIOA funded youth programs are required to have a certified Life coach. CRY-ROP participated in the, "At Life" project and served some of those students. They still have WIOA funded programs and would like to leverage the existing Life coaches.

Mr. Arellano commended the students for having the courage to ask for help and asked them to, "Pay it forward and be the ambassadors," he wished all 3 much luck.

Mitch Rosin elaborated on this report and he talked about the possible renaming of AEBG, possibly getting rid of the, "BG" since it is not a block grant rather a continuous source of funding.
