Mitch talked about GED Flash and how they are looking to pilot, they will be giving 25-35 vouchers. It is an online interactive tool that functions similar to traditional flashcards, helps students prepare for each subject, and build confidence step by step. Colton Joint Unified School District and Inland Career Education Center would like to volunteer for the pilot.
