# 2.1 Year 1, Year 2, and Data & Accountability Funding Streams

Emma Diaz summarized the funding streams that the Inland Adult Education Consortium has right now:

- Year 1 funding can be used up until December 31, 2017. Total allocation is \$2,996,771.00: \$2,000,000.00 to K-12 and \$996,771 at the Fiscal Agent. All contracts are with each district.
- Year 2 funding can be used up until December 31, 2018. Total allocation is \$9,869,529.00 + \$91,965.00 = \$9,961,494.00: \$8,907,758.00 to K-12 and \$1,053,736.00 at the Fiscal Agent. All contracts have been sent out to each district.
- Data & Accountability can be used up until December 31, 2017; it is a one-time funding stream. \$494,311.00 at the Fiscal Agent; the plan is due by December 20, 2016.

## 2.2 2015-2016 AEBG Student Data Collection

Emma Diaz reported that the 2015-2016 AEBG student data collection (consortium duplicated enrollment by program area) was successfully submitted on August 1, 2016.

# 2.3 2<sup>nd</sup> Annual AEBG Summit

Emma Diaz shared that the State is allowing 4 to 5 representatives from each consortium to attend the 2<sup>nd</sup> Annual AEBG Summit in Sacramento. The State recommendation is that at least one faculty member attends.

Dr. Cuauhtémoc Avila and Jerry Almendarez confirmed their attendance in representation of the Inland Adult Education Consortium.
