# 2. Reports

# 2.1 <u>State AEBG Office Update</u>

Emma Diaz shared with the Inland Adult Education Consortium the San Bernardino County AEBG Consortia breakdown which is composed of 5 AEBG Consortia, 33 K-12 districts, 7 Community Colleges, the Workforce Investment Board, and 3 ROPs. She talked about the impact the Inland Adult Education Consortium is having by being the largest in the County:

•	Inland Adult Education Consortium (49%)	\$9,961,494
•	Chaffey (West End Corridor) (34%)	\$6,883,501
•	Victor Valley (10%)	\$2,069,315
•	Barstow (4%)	\$860,324
•	Morongo Basin (3%)	\$773,016

Emma also highlighted the language from the Governor's Proposed Budget for 2017-2018 Investing in California Workforce: Adult Education Block Grant Program – This program coordinates representatives from local educational agencies, community colleges, and other regional education, workforce, and industry partners to promote the educational opportunities offered to students and adult learners. Through this program, students and adult learners can access courses to complete their high school diplomas or general education equivalent, English as a second language courses, and pathways courses that lead to additional career opportunities. The budget includes \$500 million "ongoing" Proposition 98 General Fund to support the Adult Education Block Grant Program.

## 3.1 Executive Committee Retreat

Emma Diaz reminded the Members that the AEBG Executive Committee Members' Retreat is set for Monday, March 6, 2017 for a full day; Neil Kelly, CCCCO Specialist, Career Education Practices, will attend the afternoon portion. Fiscal decisions will be made: CFAD fiscal declaration review of 2015-16 fiscal activity and Fiscal Agent vs. Direct Funding (impact 2017-18 funding). Program area priorities: review data on enrollment for 2015-16 and a planning day in June for the Annual Plan will be set up. To prepare for the Retreat, Ms. Diaz asked the Executive Committee Members what kind of data or information could she provide to help them make decisions and whom should attend the meeting?

Lori Rhodes requested the following: a list of programs that were invested in this year, the data that shows what was implemented, the allocation amounts, what are the next kind of programs that would be added, the gap data, the growth, and what would be the next steps. Ms. Rhodes also recommended that only executive members attend the Retreat to be able to focus on planning goals and to move the presentations to the June meeting.

Dr. Avila requested the data on students, measure of program quality, and student retention/completion.

Cali Binks requested information on program fidelity, transition data, performance outcomes, consortium goals, revisiting the steps, what kind of progress was made, and what kind of progress needs to be made. Ms. Binks recommended Reg Javier, Executive Director, San Bernardino County Workforce Development, to present on the data that will be collected and a partnership update during the June meeting.

Ms. Alvarez recommended a WIOA update since not everyone is able to attend these meetings.

Richard Galope talked about the possibility of a county-wide matrix of all the different stakeholders' funding sources that can be meshed together and the Strong Workforce Program funding for the community colleges in the region.

Dr. Bautista recommended a summary or presentation on the Strong Workforce Initiative of this area.
