3. Reports

3.1 Regional Professional Development Share-Out Day

Emma Diaz reported that the share out day was held on June 9, 2017 at the Inland Career Education Center. Over 100 attended; all districts were represented. During lunch, they socialized and networked between program areas and shared best practices. Some of the breakdown sessions were presented by the Inland Career Education Center staff; these sessions tied directly with some of the deliverables we have for the grant. It was a successful event!

3.2 ABE/ASE/ESL Assessment Committee – Field Team Representative

Emma Diaz shared that the State has 3 Field Team Committees:

- Data and Accountability
- CTE Assessment
- ABE/ASE/ESL

The purpose of the Basic Skills Assessment Field Committee is to propose definitions for performance outcomes, measurable skills gains, and assessment processes for adult learners in consortia receiving AEBG funds.

WestEd issued 2 White Papers for each Field Team and used the information for the Legislative Update to the State.

3.4 Data Reporting: August 1st Student Data Submission

Emma Diaz talked about the data reporting deadline of August 1, 2017; everyone successfully submitted data. The consortium data submission total, not including the college, was 7,408 students enrolled in 7 AEBG program areas; it is impressive that it grew by 1,100 students in one quarter.

Dr. Baustista talked about the numbers being incorrect due to 700 students of the Inland Career Education Center not fitting within the 7 AEBG program areas. CASAS is working on a report but ICEC does not have the capability yet.

7.3 Bob Marzano and Make Hope Happen Foundation

Dr. Marsden shared that he has been working with a non-profit organization Bob Marzano and the Make Hope Happen foundation to help develop a product that will be free to students. We are working currently with 20 students ages 18-24 that are in foster care or homeless, using predictive analytics, the goal is to help drive the students' future and put them in a path to success. They are coupled with a live coach. Once beta testing is done, Dr. Marsden would like to present it to the Inland Adult Education Consortium Executive Committee body.

7.4 <u>District Student Leadership Summit</u>

Jerry Almendarez thanked President, Diana Rodriguez for hosting the summit at San Bernardino Valley College. The summit will consist of over 500 students from middle school and high school with sessions in building leadership capacity, leadership beyond high school, bullying and anti-bullying, and how do leaders address bullying when encountered. We are welcoming students from other districts.
