3.1 Federal Update on WIOA II (AEFLA) Mitch Rosin presented:

An update from Capitol Hill from the PRISM group: the funding has not been released yet. The state letters were sent to each of the 57 states and territories. It is highly unlikely that a budget will be passed by the September 30th deadline, so a government shutdown is possible.

- Here is a timeline of the last 10 years. You can see where we initially stood with \$500 million and where we are today with \$668 million. There's been incremental growth every year that shows the dedication that our state has to adult education funding.
- Mr. Dana Carter stated that we have received funding at the same rate as K-12 schools for the last few years. 28 states depend entirely on WIOA funds.

- were closed and the duration of those closures. She is very aware of how these factors affect our enrollment.
- We have now surpassed 9,000 students, demonstrating our dedication and persistence in helping them return to school.



- Colleges report their progress differently. We've made a significant investment by hiring four full-time transition counselors who work directly with students at the adult education sites.
- The metrics capture several key factors regarding student engagement. For example, do students complete an application? Do they attend orientation? Are they working on placement? Do they create an educational plan? How many actually register for classes? This data pertains specifically to Valley.
